

President's Report – Sharon Mitchell

The League of the CSOA has had an extremely exciting year filled with varied volunteer opportunities and successful events. My message and goal, as the President of the League of the CSOA, is to revisit our original mission and purpose. Our mutual passion for classical music, our pride in the beloved CSO, and our fervent desire to serve are the initial ingredients that bring us together. Volunteering for the numerous children's concerts (AIM), the senior and veterans' rehearsals (SVEP), as well as the Crain-Maling Foundation CSO Young Artist Competition and the significant assistance our League have contributed to the CSOA for the yearly Open House Chicago events are essential examples of our vibrant spirit of volunteerism.

Our visibility comes from this volunteerism! Visibility is essential in growing our membership. My aspirations are that our League membership reflects our community and our school concert audiences, and that we share and interact with other CSOA organizations. We have enjoyed several events with the Women's Board and co-sponsored a reception with the Overture Council for the Civic Orchestra musicians. Additionally, the Executive Committee mirrors shared membership with the African American Network, the Latino Alliance, and the Women's Board.

Last March we were able to host the CSO Chorus for our traditional Endowed Concert Reception for the first time since 2019, due to Covid-19. League members also enjoyed attending Fall in Love with Music, the Musicians' Luncheon, Corporate Night, a tea honoring our 30-Year League members, as well as our three traditional Membership Meetings.

Last Year marked a new focus: Musician Engagement. Bobbie Huskey served as the first chair of the committee and Susan Synnestvedt was our first CSO musician ambassador. We also enjoyed celebrating with the Civic Orchestra musicians at two post-concert receptions which has become a League tradition. We also enjoyed stuffing goodies in the red League canvas bags for the Civic musicians for their annual Bach Marathon, also a League tradition, long remembered by those young professional musicians.

A particularly vital component of our mission is to share financially, by paying our dues, making our Annual Fund contributions, supporting sponsorships for Fall in Love with Music, and Corporate Night, and making Tribute Fund donations, which supports our Civic Orchestra fellow, and, as well, purchasing CSO concert and event tickets.

I want to thank each League leader, especially the Executive Committee, that I fondly refer to as the "Dream Team," whose names are listed with their VP reports. Our 2023-2024 season was filled with students, seniors, veterans and our lifelong patrons!






VP of Areas & Salon – Margo Oberman

Since the League calendar was full for the fall of 2023, we had a Zoom with Melanie Kupchynsky on March 4th, 2024. Melanie spoke about her book, "Strings Attached" that she wrote with Joanne Lipman. It is a wonderful, inspiring story of a teacher who pushed his students to do more than they thought they could and changed their lives. "Strings attached is a testament to the astonishing power of hope—and a celebration of the profound impact one person can have on the lives of others. That one person was Melanie's father. Yo-Yo Ma is quoted as saying, "this book makes me believe that one man can make a difference. The Zoom took place in the 8th floor Conference Room, and we had approximately 50 attending the Zoom and raised over \$700 for our League Civic musician. VP of Education – Sue Bridge

Summarizing all the activities of the Education Committee into one or two pages is a real challenge. Here is a condensation of all the program in which so many of our League members helped to make them successful:

1. Adventures in Music Program (AIM) – Chair by Kathy Nordmeyer

In this program, 27 League members committed 317 hours of their time in support of AIM concerts this season. These concerts included pre-school concerts (age 3-5), elementary school concerts (age K-6) and concerts for age 6 and up to high school. We saw nearly 20,000 students along with their teachers and chaperones in 23 AIM concerts. Amazing educators and chaperones joined our members to help ensure that the young people of Chicago had an extraordinary experience. We aim to host a new record of 21,000 guests in our next season and enjoy every moment of the concerts ourselves.

2. CSO Crain-Maling Foundation Young Artists Competition

Under the direction of the Negaunee Institute and our League co-chairs, the preliminary competitions were held on January 13, 2024, and the final competitions were held on February 24, 2024. This year's competition was unique which involved young musicians on a wide spectrum of instruments including oboe, horn and clarinet. This led to a truly engaging and impressive group of finalists: Elyse Schlesinger (horn), Chloe Nam (flute) and Jaden Teague-Nunez (steelpan). Jaden was chosen as the winner and will perform with the Chicago Symphony Orchestra next season. Elysse was the League's guest artist at this spring's Annual meeting. The judges also chose three competitors to receive summer scholarships. They are Madison Barber on oboe, Julian Kolthammer on horn and Christopher Chung on clarinet.

3. Community Engagement Program (Senior & Veteran)

The 2023-2024 concert season gave us all the opportunity to enjoy a wide variety of superb conductors. We were hoping that those guest conductors would embrace the tradition of inviting seniors and veterans and community centers from across

Chicagoland to attend three Open Rehearsals during the spring season. We were not disappointed. On February 29, April 17 and June 5, Orchestra Hall welcomed hundreds of excited guests to enjoy great concerts which they might otherwise have been prevented from attending because of financial, physical or transportation concerns. We are looking forward to continuing this rich and vital tradition in the 2024-2025 season.

4. Community Engagement Docent Program

Our 7 dedicated docents provided 25 well prepared presentations at 12 varied venues for 3 rousing rehearsals during 2023-2024 concert season. The engaging talks were accompanied by slideshows filled with audio examples and video excepts for attendants a better understanding of the composers and their music. The joy and appreciation from attendants at the sessions is immeasurable.

There were many wonderful events held in the 2023-2024 season. The endowed concert reception was held on April 13, 2024, Musician Luncheon was held on May 2, 2024, Civic post-concert reception was held on May 3, 2024, and CSO post-concert reception was held on June 14, 2024.


3. Civic Post-Concert Reception

VP of Finance – Mary Beth Dietrick

The League supports the CSOA in many ways, reflecting the efforts of many volunteers. These activities help to promote appreciation of symphonic music and to encourage a commitment to music education. We also raise funds, either through direct contributions or through events that generate revenue.

At the beginning of this fiscal year the League increased its dues and its required Annual Fund contribution from \$100 to \$150. This was well received, most likely because we hadn't asked for an increase for many years, and the benefits make these amounts look like real bargains!

Annual Fund

Each volunteer organization has its own Annual Fund, with its own goals. For the League, it is one of the highest targets for revenues. At the end of the fiscal year the money is transferred to the CSOA's Annual Fund, to be used wherever needed. Our goal this year was \$100,000 – a reduction made to reflect the reduced number of members. Your annual fund contribution can be made at any time before June 30th, 2025.

Tribute Fund

This fund can be used at the League's discretion. For several years we have funded a Civic Fellow from this fund. Our contribution this year for that purpose was \$9500. Our Civic fellow was cellist Lindsay Sharpe. Our goal for 2023-2024 is \$10,000, as the amount of the Civic stipend has increased. We will have a new Civic fellow. A contribution to the Tribute Fund is a great way to thank someone, congratulate someone, or recognize the memory of a loss.

Membership Dues

This number comes close to matching the number of members. Active members pay \$150 per year and Supporting members pay \$250 per year.

The revenue is raised by the League's tickets for its reception and donations.

The revenue is also raised by ticket sales and donations.
